CORONAVIRUS BUSINESS SUPPORT SCHEME: BUSINESS GRANTS



The Coronavirus Business Support Fund, announced by the government to provide grants to small businesses during this time, has now opened for applications. There are some restrictions on who can apply for this, which are based on the rateable value(s) of non-domestic properties occupied and rates relief already provided.

The deadline for application for both of the below grants is 31 March 2021.

Small Business Support Grant (£10,000)

To obtain the £10,000 grant offered, you must meet the following conditions:

- 1) You must be in receipt of non-domestic rates relief (Small Business Bonus Scheme relief, Rural Relief, Nursery Relief, Business Growth Accelerator Relief or Disabled Relief)
- 2) The rateable value of your premises is £18,000 or less or, if you have more than one premises, the combined total must be £35,000 or less

If you meet these conditions, then applications should be made to your local authority through forms available on their website. Retail, Hospitality, Leisure Support Grant (£25,000)

To obtain the £25,000 grant offered, you must meet all of the following conditions:

- You must be in the retail, hospitality or leisure sector (Examples of types of businesses/organisations included per Edinburgh Council can be found in Appendix I of this document, and other councils at https://www.mygov.scot/non-domestic-rates-coronavirus/)
- 2) Your business premises must have a non-domestic rateable value between £18,001 and £50,999

If you meet these conditions, then applications should be made to your local authority through forms available on their website, using the same link shown above.

State Aid

Section 6 of the applications ask for details of state aid received. If you have received R&D tax credits or government grants, please get in touch as these will need to be disclosed within this section.
